In considering whether to exclude the public and press from the next part of the meeting Members are asked to consider the following factors when determining the public interest test.

Agenda Item 14 - Not for publication by virtue of Paragraph 14 and 15 of Schedule 12A to the Local Government Act 1972 (as amended). The Proper Officer has determined in considering this report that Paragraphs 14 and 15 should apply. His view on the public interest test was that while he was mindful of the need to ensure the transparency and accountability of public authorities for decisions taken by them in relation to the spending of public money, in relation to Paragraph 14, the right of the authority or a third party to the privacy of their financial/business affairs outweighed the need for that information to be made public. Disclosure of the information would give an unfair advantage to tenderers for commercial contracts. In relation to Paragraph 15 he was satisfied that in this case disclosure of the information would prejudice the discussion in relation to labour relations to the disadvantage of the authority and inhabitants of its area. On that basis he felt that the public interest in maintaining the exemption outweighs the public interest in disclosing the information. This information is not affected by any other statutory provision which requires the information to be publicly registered.

It is, therefore, recommended that the press and public be excluded from the Meeting during consideration of the following item as it is likely that, if they were present, there would be disclosure to them of exempt information as defined in Paragraphs 14 and 15 of Part 4 of Schedule 12A to the Local Government Act 1972 (as amended).
